The problems observed

Following years of experience in the market we have observed the following problems faced by the Companies:

- No correct Cash Flow check is performed, therefore, most of the Companies are facing Cash Flow issues. Many times the non-informed shareholders/owners perform dividend payouts or personal withdrawals higher than what the Company 'produces' resulting in higher Cash Flow issues;


